

2026 Organizational Meeting

Meeting minutes

Call to Order/Roll Call

The Organizational Meeting for the Town of Leicester, held at Town Hall, 132 Main Street Leicester, NY 14481, was called to order on Monday, January 5, 2026, at 7:00 p.m.

Pledge to the Flag

The Meeting began with the Pledge of Allegiance to the Flag led by Deputy Supervisor Jason Yasso.

No Members of the Public were in attendance.

Oaths of office

Town Clerk, Amy Neumann administered the Oath of Office to Council Members Jason Yasso and Matthew Durbin, who were reelected in the Special Election held in November 2025. They were sworn in for a three-year term commencing on January 1, 2026, and ending on December 31, 2028, in accordance with the Even Year Law. Both Councilmembers signed their Oath documents.

Supervisor White noted for the record that a Legal Notice about the Organizational Meeting had been published in the Livingston County Newspaper, dated December 10, 2025.

Dennis Prevost was Appointed as the Primary Representative, with Russell Page serving as the Alternate.

Amy Neumann was Reappointed to these positions.

Other Appointments

Highway Superintendent Appoints Deputy

The Highway Superintendent Appointed Todd Lubanski as Deputy Highway Superintendent with a pay stipend of \$1.50 per hour, consistent with the present Union Contract.

Town Clerk Appoints Deputy

Town Clerk Amy Neumann Appointed Kim Reitz as Deputy Town Clerk, Deputy Register of Vital Statistics, and Deputy Tax Collector.

Other Designations

Supervisor White reviewed the following designations for 2026:

- Official Town Bank: Five Star Bank and NY Class
- 2026 Mileage rate to follow IRS rate, currently 72.5 cents per mile
- Approval for the Town Clerk/Tax Collector to set up a \$200.00 petty cash fund to be returned to the Town at the end of the 2026 Tax Warrant
- Approval allowing the Highway Superintendent to spend up to \$5,000.00 for supplies and materials for 2026
- Official Town Newspaper: Livingston County News
- Pay Rate for the Board of Assessment Review at \$75.00 per meeting
- Pay Rate for Planning Board Members and Zoning Board Members at \$25.00 per meeting
- Town Hall hours will be 8:00 AM to 4:00 PM Monday through Friday, closed for all National Holidays
- Town Board Meetings will be held on the second and fourth Tuesday of each month at 7 PM, unless otherwise posted
- Approval for advance payment of utility bills, postage, freight charges, and contractual health insurance payments

- As approved in the 2026 Budget, all hourly rates outside of any bargaining units will increase by 5% as of January 1, 2026. All Elected and Appointed officials will also receive a 5% increase, which was published as required by law.
