NEW BUSINESS:

Attorney; Jim Campbell – New water district. Town process not an authority process. Town must form a district and the people that are in that district must pay for the project. Town board can create district and that is subject to permissive referendum and the only people that can get petitions against such proposed district or for such district must live within the proposed district. Map Plan and report for rough plan of improvements. Cost attributed to the cost of the improvement. If you approve

the district, it cannot exceed the amount that was approved to the project. All steps must be followed. Online surveys, mailers, and cost surveys. Informational meetings. Online surveys seem to be the most effective. The engineer will provide a cost for the map plan and report, and this is passed by resolution, ranging \$7,000.00 to \$10,000.00 in cost. Prevost went to Lima meeting and had a vested interest up the road from here.

The district must be defined. This starts with a map plan and report, the Town attorney, James Campbell explained. A New tower is being proposed in the Letchworth Park and Murray hill for a regional water project. (35:39 recorder)

Source Supply is in question and if there is no water, there is no project. James Campbell, two factors that are true in each project. There are people that want water and cannot get it and there are people that can get water that don't want it. Supervisor Rich White said most likely the source of water will most likely be coming from Conesus, Hemlock, and possibly Rochester.

Town Attorney, Jim Campbell suggested having Jason Molino come in to talk about what's around the corner for water. At least 2 years out in 2026, if everything moves right along.

Prevost is asking if we are going to invite. And that is all for the survey. Supervisor White will ask Jason Molino to join us.
