Water Rate Increase: A Motion was made to table the water rate increase by Councilmember Gerald Hull and Seconded by Councilmember Matthew Durbin. Motion carried. Ayes 4, Noes 0.

**Cell Tower report from Town Attorney, James Campbell:** Received the proposed ground lease from Tarpon Towers, anchor tenant will be Verizon. 6-year conversation and at \$1000.00 per month and 2 percent increase annually and they will be building their own Tower with 5-year contract with 6 possible 5 year extensions. Co locators on same tower would increase the rent by \$250.00 per co locator exceptions are 911 and EMS that doesn't pay. Hope to hear back shortly. You would by resolution authorize the Town Supervisor to sign the lease and is subject to a permissive referendum. The Town Board would like the Town Attorney to continue the process forward.

Deputy Supervisor asked if there was anything else to come before the Town Board. Hearing none he Thanked the public for coming and knows this was a frustrating situation for the public and for the Town Board as well but good to hear from the public on these matters.
