Old Business:

Cuylerville Fire Contract: Fire Chief Frank Radesi, and EMT Jennifer Johnson will be at the next Town Board meeting, Tuesday, March 21, 2023, at 7:00 p.m. to answer all questions on the financials that were presented to the Town Board tonight from Treasures.

SAM Update: Town Clerk completed SAM renewal; new expiration date is February 28, 2024. Supervisor Fanaro explained this must be completed yearly for the Town to receive Grant Funds.
